

## LIABILITY AND INDEMNITY

**Please read the following conditions carefully as they contain important terms relating to your experience booked with Sand Sherpa LLC (an NPIMEDIA Group company).**

**As a participant in Sherpa Drive with Sand Sherpa, I understand and agree that:**

- I have presented a current and valid UAE/International Driving License to my guide before starting the experience and am carrying the same current and valid credit card used for my booking.
- I understand that any damage caused to the vehicle while I am operating it will result in liability for repair charges of up to AED5,000. A guide will also assume control of the vehicle following any incident for the remainder of the experience.
- I understand and accept that a guide may take over the operation of my vehicle at his/her sole discretion during the experience and that I may also request their assistance at any time.
- I will follow the instructions of my guide and comply with the rules and regulations of driving in the Dubai Desert Conservation Reserve (DDCR) as communicated during the briefing for the experience and over radio during the drive.
- I understand that a DashCam video recorder is fitted to the vehicle I will be operating and/or travelling in and undertake not to interfere or adjust the settings of this video recording device which is set to operate automatically, filming the external environment to the front and rear of the vehicle (interior of the vehicle is not captured on video).
- I will keep the handheld radio on at all times and set at a volume that myself and passengers may hear.
- I understand that any failure to follow instructions and abide by the rules of DDCR may result in my experience being suspended, whereby a guide will assume control of the vehicle and may decide to proceed with the experience, or return myself and my party to the point from which we were collected at their sole discretion.
- I undertake to treat all employees of Sand Sherpa respectfully and acknowledge that the company operates a zero tolerance policy towards the abuse of employees, including the use of profanity and failure to comply with instruction and requests.
- I agree to wear a seatbelt at all times when seated in the vehicle and ensure that all my passengers are also wearing seatbelts.
- I agree to maintain safe distance from other vehicles as communicated by my guide.
- I agree to take full and sole responsibility for the loss/damage of my belongings while on this experience and hold Sand Sherpa LLC and its employees harmless in this regard.
- I agree to maintain environmental consideration at all times and will not leave waste behind and interfere with natural habitats.
- I assume full responsibility for the safety of myself and my passengers when driving the vehicle assigned to me by Sand Sherpa LLC and hold the company and its employees harmless from claims relating to any injuries or fatalities that may occur to myself or my passengers while the vehicle is under my operation and while I am participating in experiences with Sand Sherpa LLC.

**Note:**

- Every vehicle is assigned a guide who oversees the safe operation of the vehicle under their guardianship.
- Even when being driven by a participant, the guide may help and take control of the vehicle under any circumstance where he/she determines that safety is at risk - both to the vehicle and to participants.
